

1) The material has to be delivered in the premises of SWL at 1 Foreshore Road, Howrah 711 102.

2) Delivery Schedule:

Delivery within 45 days (in Stage I) and 60 days (in Stage II) from the date of receipt of order/LOI.

Stage I: Bearing Housing with Stuffing Box

Stage II: All other balance items of the related drawings (as per BOQ).

3) Scope of Supply & Work:

- Fabrication of Rudder including supply of all related materials as per drawing.
- Manufacturing of Rudder Stock and all related components as per drawing and as specified in the material list.
- Bedding of Rudder with Rudder Stock palm surface and bedding of upper Rudder Stock (taper portion) with Tiller Arm supplied by Steering Gear supplier. Bedding of the Tiller and Rudder Stock may be carried out at supplier's or SWL premises.
- Final machining of the Rudder Stock's Tiller portion to be done on receipt of Tiller from the supplier, however one Tiller's sketch is enclosed for reference.
- Any discrepancies or short comings observed during installation in regard to mismatch of components/unsatisfactory bedding, to be carried out by the bidder at SWL premises without any additional cost.
- Minor changes may be there from the supplied drawings (during tender). However, final dimensions of any part of the assembly will be intimated during placement of the order, if so require.

5) Terms of Price:

8) Inspection:

Pre-despatch inspection may be carried out by SWL/IWT at supplier's premises, if require. However, after receipt of materials at SWL yard, all the components will be inspected by SWL. Manufacturer's Test Certificate/Material's Test Certificate from NABL Accredited Labs to be submitted during inspection.

9) Terms of Payment:

20% on completion of supply of materials of Stage I, 70% on completion of supply of materials of Stage II. Balance 10% after expiry of guarantee period or against submission of PBG of equivalent value valid for contractual guarantee period.

10) Risk Purchase:

In case of delay/failure in delivery beyond the contractual period, SWL shall have the right to cancel the order and procure items from alternative source at Bidder's complete risk and cost.

11) Guarantee/Warranty:

The materials are to be guaranteed for satisfactory performance for a minimum period of 12 (twelve) months from the date of supply and acceptance. Any defects arising within the guarantee period towards manufacturing and performance are to be liquidated forthwith, by replacement, if required. Manufacturer's Test Certificate & Guarantee Certificate are to accompany the supply.


16) Court:
