SECTION – B SPECIAL TERMS AND CONDITIONS

(i) The work has to be carried out in the premises of SWL at 1 Foreshore Road, Howrah 711 102.

(ii) Date of Completion:

Completion within 45 days from the date of receipt of order / as advised at the yard in line with delivery of the vessel.

(iii) Order acceptance:

The final evaluation will be made based on total price quoted by the bidder.

(iv) SWL's Scope of Supply:

- a) All varieties of chairs, sick bed, materials as necessary for fabrication of chair base/cleats, fasteners and any other related materials pertaining to fixing of the chairs over the deck.
- b) Working space, water, electricity, lighting, materials handling facilities as required.
- c) Reference drawings.

(v) Contractor's Scope of Supply and Work:

- a) Transportation of all materials from store to working site.
- b) Proper cleaning of the deck area, fabrication and securing of the base/foundation/cleats necessary for fixing up of the chairs/bed as per drawing or instruction from the SWL site engineer.
- c) The works should be in compliance to the requirement of IRS and WOT.
- d) Providing of unskilled, semiskilled and highly skilled manpower for carrying out the subject work.
- e) Providing of platter, gas cutter, IRS qualified welder etc. including supply of welding machine, gas cutting set and all necessary consumables viz. gas, electrodes, grinding wheel etc. and any other standard/special tools necessary to complete the subject work.
- f) Any other work and minor materials beyond the scope of supply/work of SWL not indicated above but required for successful completion of the work are to be considered within the scope of the vendor.

Note:

- a) The successful bidder has to take-up the job immediately on finalisation of the contract/order on receipt of LOI/P.O. Detailed work plan in consultation with SWL authority is to be submitted before commencing the job.
- b) Utmost care has to be taken during execution of the job to avoid any damage of the supplied chairs/beds and any other machineries/items installed therein. Wilful damage has to be compensated in full.
- c) Safety of persons engaged in the job is vendor's responsibilities and formalities are to be observed as per rule.

(vi) Variation in Work:

SWL shall have the right to make variation in the BOQ of the tender at the time of execution of the work. In case of upward variation in the item quantity, contractor will be bound to execute the work as per the BOQ approved rate.

(vii) Inspection:

Inspection will be carried out by the representative of SWL, WOT (Kolkata) and IRS wherever necessary.

- (viii) Price: To be quoted in INR but excluding of GST.
- (ix) Taxes: As applicable.

(x) Terms of Payment:

Payment will be made in stages/pro rata basis depending on progress of acceptable quantity of the job. Bills are to be submitted enclosing actual work done duly certified by SWL representative. 90% of each bill shall be paid within 30 days from the date of submission. Balance 10% of the stage bills will be retained and released on completion of work subject to submission of Bank guarantee of equivalent amount as per SWL format from any scheduled bank with a validity of 12 (twelve) months from the date of completion of work.

(xi) Liquidated Damage (L.D.):

In the event of delay in execution of the work due to the reason attributable to the sub-contractor, liquidated damage @0.5% per week's delay or part there of subject to a maximum of 5% of the order value shall be levied and recovered from the sub-contractor.

(xii) Risk Purchase:

In case of failure in executing the contract as per terms mutually agreed upon, SWL reserves the right to cancel the order and engage any other agency out-source the job from any other firm at the risk and cost of the vendor.
