## SECTION – B SPECIAL TERMS AND CONDITIONS

1) **Place of Work:**

The work has to be carried out at the yard of SWL at 1, Foreshore Road, Howrah - 711102.

2) **Duration of Work/Job:**

The maximum time will be 55 days from the date of awarding of the order from SWL or from the day of arrival of vessel from IWAI, whichever is later.

3) **Bid Validity:**

Quoted rate should remain valid for 6 months from the date of opening of the Financial Bid.

4) **Evaluation of Tender:**

The L-1 price will be evaluated based on the total price of BOQ.

5) **Selection of bidder:**

The L-1 bidder will be awarded the vessel initially as will be available from IWAI. In case the performance of repairing of the awarded bidder is not found satisfactory, SWL reserves the right to cancel the order and re-award the same to next bidder. SWL also reserve the right for not indemnifying the bidder from whom the Work Order has been withdrawn due to poor performance as may be considered by SWL.

6) **Delivery Schedule & Liquidated Damage (L.D.):**

Scheduled Delivery/Completion is 55 days from the date of awarding of the order from SWL or from the day of arrival of vessel from IWAI, whichever is later. In the event of delay in delivery beyond contractual period, SWL shall have the right to recover Liquidated Damages @1.5% per month of delay to be computed on per day basis subject to a maximum of 10% of the Order value.

7) **Contractor's Scope of Supply and Work:**

- a) Qualified welders, skilled & unskilled workmen, competent site in-charge, supervisor, consumables like class approved radiographic quality all position electrodes (Brand ESAB/ADORE/ROYAL), Gas cutting, welding machine with accessories, grinding machines and grinding wheels, cutting wheels, industrial gases, drilling machine, tools & tackles, blowers, safety items required for workmen & any other related accessories.
- b) All materials required to complete the repair of the vessel as per the scope of work.
- c) Transportation of materials to work site from the respective source of procurement.
- d) Work to be carried out as per the Job Schedule stipulated in Section C.
- e) Any other work and minor materials beyond the scope of supply/work of SWL not indicated above but required for successful completion of the work are to be considered within the scope of the vendor.

**Note:**

- a) The successful bidder has to take-up the job immediately on finalisation of the contract/order on receipt of LOI/P.O.

**8) Variation in Work:**

**9) Inspection & Survey:**

Inspection shall be taken up by SWL, IWAI, IRS and IWT Directorate as and when required, in stages and also after completion. The jobs are to be carried out as per direction of SWL and with close liaison among departments of SWL, IWAI, IRS and IWT Directorate. **IRS & IWT Survey fees will be borne by SWL.**

**10) Price:**

To be quoted in INR by percentage over the total value as stipulated in BOQ. GST will be extra as applicable.

**11) Taxes:**

The bidder shall be solely responsible for the payment of GST and other taxes, if any levied by the Government and other local bodies from time to time.

**12) Performance Guarantee & Security Deposit:**

- a) The contractor shall be required to deposit an amount equal to 5% of the tendered value of the work as performance guarantee in the form of either RTGS payable at any nationalized/schedule bank OR an irrevocable bank guarantee bond of any scheduled bank or State Bank of India in accordance with the format provided by SWL within 15 days of the issue of the work order. Performance guarantee shall be initially valid up to the stipulated date of completion plus sixty days beyond that. - b) A total amount of 5% of bill value will be deducted and retained as Security Deposit from R/A bills, which will be released after expiry of warranty period of 1 (one) year from the date completion and commissioning of the Project. Bank Guarantee will not be accepted as Security Deposit.
- c) No interest will be paid on performance guarantee & security deposit.
- 13) **Work Done Certificate (WDC):**  
Work done certificate based on the actual work done to be submitted duly signed by the authorised representative of SWL. This WDC will have to be submitted at the time of raising R/A bill(s).
- 14) **Terms of Payment:**  
a) Payment to the extent of 95% of the value of R/A bill(s) [excluding taxes] will be done within 30 (thirty) days after satisfactory completion of total job and issuance of WDC matching with actual Work Done. b) Remaining 5% will be released after completion of 1 (one) year guarantee/warranty period.
- 15) **Risk Purchase:**  
In case of delay in execution of the work beyond the contractual completion period, SWL reserves the right to out-source the job from any other firm at the risk and cost of the vendor.
- 16) **Prevention of Damage:**  
Utmost care has to be taken during work at SWL premises to avoid any damage/loss of company's materials, machineries. Wilful damage has to be compensated in full as evaluated by SWL. Safety of sub-contractors men and materials shall be their own responsibility. All rules applicable for working within PSU premises are to be adhered to.
