# SECTION – B SPECIAL TERMS AND CONDITIONS

#### (i) Scope of Supply:

#### (iii) Terms of Price:

Quoted price shall be firm and fixed till full execution of order and shall be on F.O.R. SWL Howrah basis inclusive of all charges except GST.

#### (iv) <u>Taxes</u>:

G.S.T. extra as applicable at the time of supply.

#### (v) Terms of Payment:

100% payment within 7 (seven) days after supply & acceptance of the materials at SWL yard.

#### (vi) Place of Delivery/Work:
