## SECTION – B SPECIAL TERMS AND CONDITIONS

- 1) The work has to be carried out in the premises of SWL at 1 Foreshore Road, Howrah 711 102.
- 2) Completion Time:  
60 days from the date of receipt of work order / as advised at the yard in line with launching and delivery of the vessel.
- 3) Order acceptance:  
The final evaluation will be made based on total price quoted by the bidder.
- 4) Considering the nature of work and to avoid disturbance of other works in connection with the same vessel, the contractor may have to engage their workmen at Night to carry out the blasting job. The same should be done in consultation with SWL authorised site-in-charge or as advised by SWL.
- 5) It also shall be the responsibility of the successful bidder (sub-contractor) to provide the Guarantee of the paints in regard to proper application of the paints onto the vessel.
- 6) SWL's Scope of Supply:
  - a) Worksite, water, electricity (as long as CESC supply is available).
  - b) All paints and thinner as necessary to complete the work.
- 7) Contractor's Scope of Supply:
  - a) Skilled, unskilled workmen, competent site in charge, supervisor, electrician, tools and tackles, scaffolding, electrical board with cable and hand lamps, vent fans etc.
  - b) For sand blasting, necessary compressor with operator, diesel for running compressor, required quantum of good quality sand, tank with required length of pipes, pressure gauges etc.
  - c) For painting, Airless Spray Machine with adequate number of nozzles and other accessories, different sizes of necessary brushes and any other tools to complete the work.
- 8) Contractor's Scope of Work:
  - a) Transportation of materials to worksite from SWL store/paint store.
  - b) As per respective scheme of painting the same to be applied with proper care and Ship-building practise.
  - c) Surface preparation to be made to SA 2.5 by sand blasting followed by 1 (one) coat of primer immediately thereafter.

- d) The blasting to be made on external and exposed area of the entire vessel as detailed in the technical specification under Section-C. Total blasting area approx. 2204 Sq. Meter.
- e) Mechanical cleaning of the internal area of hull and superstructure to be carried out with necessary mechanical tool and accessories approx. 3656 Sq. Meter.
- f) The painting to be made on both external and internal area of the total hull and superstructure including both ramps as detailed in the technical specification under Section-C. Total painting area approx. 17886 Sq. Meter.
- g) All the coats to be applied by Spay Painting Machine, except some places, where brush painting is inevitable.
- h) No additional cost shall be entertained in case of any minor work to be carried out.

## Note:

- i) The successful bidder has to take-up the job immediately on finalisation of the contract/order on receipt of order/LOI. Detailed work plan in consultation with SWL authority is to be submitted before commencing the job.
- i) Utmost care has to be taken during execution of the job to avoid any damage including machineries/items installed therein. Wilful damage has to be compensated in full.
- ii) Safety of persons engaged in the job is vendor's responsibilities and formalities are to be observed as per rule.

## 9) Variation in Work:

SWL shall have the right to make variation in the BOQ of the tender at the time of execution of the work. In case of upward variation in the item quantity, contractor will be bound to execute the work as per the BOQ approved rate.

## 10) Inspection:

Inspection will be carried out by the representative of SWL & WBTC Ltd.

## 11) Price: To be quoted in INR per Sq. Meter basis.

## 12) Taxes: Taxes are extra, as applicable.

## 13) Terms of Payment:

Payment will be made in stages depending on progress of acceptable quantity of the job. Bills are to be submitted enclosing work done certificate issued by SWL. 90% of each bill shall be paid within 30 days from the date of submission. Balance 10% of the stage bills will be retained and released on completion of work subject to submission of Bank guarantee of equivalent amount as per SWL format from any scheduled bank with a validity of 12 (twelve) months from the date of completion of work.

14) Guarantee:

The job to be carried out shall withstand guarantee for a period of 12 (twelve) months from the date of completion and acceptance by SWL.

15) Liquidated Damage (L.D.):

In the event of delay in execution of the work due to the reason attributable to the sub-contractor, liquidated damage @0.5% per week's delay or part there of subject to a maximum of 5% of the order value shall be levied and recovered from the sub-contractor.

16) Risk Purchase:

In case of delay in execution of the work beyond the contractual completion period, SWL reserves the right to out-source the job from any other firm at the risk and cost of the vendor.

17) Prevention of Damage:

Utmost care has to be taken during work at SWL yard to avoid any damage/loss of company's materials, machineries. Wilful damage has to be compensated in full. Safety of sub-contractors men and materials shall their own responsibility. All rules applicable for working within PSU premises are to be adhered to.

18) Safety:

Proper safety of contractor's workmen will be completely under the responsibility of contractor at shipyard of SWL.

19) Arbitration:

For disputes arising in executing and discharge of the contract from either side the Managing Director of SWL, HRBC Office Compound, Canteen Building, 1st floor, Munshi Premchand Sarani, Kolkata – 700 021 shall act as Arbitrator between the Seller & Buyer.
