SECTION – B SPECIAL TERMS AND CONDITIONS

1) Scope of Supply:

Scope of supply & technical specification/requirement shall be strictly as per technical specification requirement stated therein as well as terms and condition of NIeT. 2) Price:

To be quoted in INR per Litre basis. The tender will be settled on total value of offers comprising of all the items. Bids offering all the items of BOQ will only be considered.

3) Terms of Price:

Quoted price shall be firm and fixed till full execution of order and shall be on F.O.R. SWL Howrah basis inclusive of all charges except GST.

4) Taxes:

G.S.T. extra as applicable at the time of supply.

5) Terms of Payment:

100% payment within 15 days after supply & acceptance of the materials at SWL yard.

6) Place of Delivery/Work:

The Shalimar Works (1980) Ltd., 1, Foreshore Road, Shibpur, Howrah – 711102 (near Shalimar Railway Station, within SWL working hours (8 AM to 4 PM) except Sundays & holidays.

7) Delivery Schedule:

Earliest delivery shall be essence of the contract. Delivery of all the materials are to be completed within 15 (fifteen) days from the date of receipt of LOI / Order.

8) Inspection:

Receipt inspection by SWL. Batch Tape Certificate is to be submitted at the time of supply.

9) Liquidated Damage (L.D.):

For delay in contractual delivery of materials, L.D. will be applicable @0.5% per week or part thereof on the undelivered materials subject to maximum 5% of the order value.

10) Guarantee:

11) Risk Purchase:

In case of failure in delivery within the contractual delivery period, SWL shall have the right to cancel the order and procure items from alternative sources at Vendor's complete risk and cost.

12) Force Majeure:

Standard Force Majeure conditions at the seller's own workshops/ establishment shall only be accepted. The failure of the sub-contractors of the seller will not be accepted as the Force Majeure conditions. Force Majeure occurrence notice will have to be given within 7 days of Force Majeure for a possible delivery extension after verification.

13) Arbitration:

For disputes arising in executing and discharge of the contract from either side the Managing Director of SWL, HRBC Office Compound, Canteen Building, 1st floor, Munshi Premchand Sarani, Kolkata – 700 021 shall act as Arbitrator between the Seller & Buyer.

14) Courts:

The contract is deemed to have been entered into Kolkata and all courses of action in relation to this contract will therefore be deemed to have arisen within the Jurisdiction of the Kolkata Courts.

15) Validity of Offer:

Offer must be kept valid for 45 (Forty five) days from the date of tender opening.

16) Acceptance:
