Supply of reputed make reverse reduction gear box to be coupled with water cooled Marine Diesel Engine (Kirloskar Oil Engine Ltd.) for propulsion systems, capacity of minimum 240 BHP at 1800 RPM, 4 Stoke, Flywheel Housing SAE 1 and Flywheel is of SAE 14. Bidders have to quote for both the items of BOQ and the bid shall be settled ship set basis
- 5) Inspection:

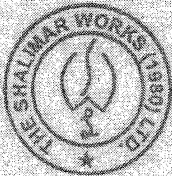
