



- 3) Order acceptance:
The final evaluation will be made based on total price quoted by the bidder.
- 4) Scope of Supply:
Any item or items not specifically mentioned in NIeT, but required for installation/smooth running of the units, should be provided by the bidder without any additional charge.
- 5) Terms of Price:
Quoted price in INR shall be firm and fixed till full execution of orders and shall be on F.O.R. SWL, Howrah basis. Price to be offered inclusive of delivery charges up to SWL yard.
- 6) Transportation charges:
NIL. To be supplied at bidder's risk & cost, up to SWL yard – 1 Foreshore Road, Howrah 711 102 are included in your scope.
- 7) Taxes:

- 9) Terms of Payment:
90% within 30 (thirty) days after receipt and acceptance of the material at SWL and balance 10% on submission of PBG for contractual guarantee period. 10) Guarantee/Warranty:

The materials are to be guaranteed for satisfactory performance for the period of 24 (twenty four) months from the date of supply and acceptance. Any defects arising within the guarantee period towards manufacturing and performance are to be liquidated forthwith, by replacement, if required. Manufacturer's Test Certificate & Guarantee Certificate are to accompany the supply.

11) Installation & Commissioning, Tests & Trials:

The successful bidder has to depute competent engineers for assistance to SWL during installation and commissioning on board. During test & trial of the vessel, technical representative are to be deputed. All the charges are to be borne by the bidder. Commissioning and trial of the Units on board are to be done at SWL yard at free of charges. Parts manuals, operation and maintenance manuals are to be supplied in 2(two) copies each.

12) Risk Purchase:

In case of delay/failure in delivery within the contractual period, SWL shall have the right to cancel the order and procure items from alternative source at Bidder's complete risk and cost.

13) Liquidated Damage (L.D.):

In the event of delay in delivery beyond contractual period, SWL shall have the right to recover Liquidated Damages @0.5% per week's delay or part there of subject to a maximum of 5% of the order value from the bidder.

14) Force Majeure:

Standard Force Majeure conditions at the seller's own workshops/establishment shall only be accepted. The failure of the Sub-contractors of the seller will not be accepted as the Force Majeure conditions. Force Majeure occurrence notice will have to be given within 7 days of Force Majeure for a possible delivery extension after verification.


16) Court:


