1) Place of Delivery/Work:

2) Delivery Schedule:

Earliest delivery shall be essence of the contract. Delivery of all the materials are to be completed within 30 (thirty) days from the date of receipt of LOI / Order.

3) Scope of Supply:

Scope of supply & technical specification/requirement shall be strictly as per technical specification requirement stated therein, as well as terms & condition of NIEt. Bidders are to follow Section B and C carefully. Any plea of ignorance shall not be accepted after opening of bids. BOQ quantity may be reduced/ increased as per discretion of SWL.

4) Selection of Bidder:

The tender will be settled on total value of offers comprising of all the items in BOQ.

5) Price:

To be quoted in INR per Running Meter basis. Variation of length +5% is accepted.

6) Terms of Price:

Quoted price shall be firm and fixed till full execution of orders and shall be on F.O.R. SWL, Howrah basis inclusive of all charges except GST. Unloading of materials at SWL site is entirely bidder's responsibility.

7) Transportation charges:

11) Risk Purchase:

In case of delay/failure in delivery beyond the contractual period, SWL shall have the right to cancel the order and procure items from alternative source at Bidder's complete risk and cost.

12) Guarantee:

The materials are to be guaranteed for satisfactory performance for the period of 18 (eighteen) months from the date of supply and acceptance. Any defects arising within the guarantee period towards manufacturing and performance are to be liquidated forthwith by replacement, if required.

13) Liquidated Damage (L.D.):

In the event of delay in delivery beyond contractual period, SWL shall have the right to recover Liquidated Damages @0.5% per week's delay or part thereof subject to a maximum of 5% of the order value shall be levied and recovered from the bidder.

14) Force Majeure:

Standard Force Majeure conditions at the seller's own workshops/establishment shall only be accepted. The failure of the Sub-contractors of the seller will not be accepted as the Force Majeure conditions. Force Majeure occurrence notice will have to be given within 7 days of Force Majeure for a possible delivery extension after verification.

15) Arbitration:


16) Court:
