Quoted price shall be firm and fixed till full execution of order and shall be on F.O.R. SWL Howrah basis inclusive of all charges except GST. Weighment of materials shall be witnessed by SWL Rep. at Weighment Scale nearer to SWL yard. The Weighment charges are to be borne by the vendor.

- (iv) Taxes: G.S.T. extra as applicable at the time of supply
- (v) <u>Terms of Payment</u>:

100% payment within 07 (seven) days after supply & acceptance of the materials at SWL yard. Offer with advance payment clause is not acceptable.

### (vi) Place of Delivery/Work:
