1) Scope of Supply:

3) Terms of Price:

Quoted price shall be firm and fixed till full execution of order and shall be on F.O.R. SWL Howrah basis inclusive of all charges except GST. Unloading of materials is entirely your responsibility.

4) Taxes: Goods and Services Tax (GST) is extra as applicable at the time of supply.

5) Terms of Payment:

100% payment within 15 days after supply and acceptance of the materials at SWL yard.

6) Place of Delivery/Work:
