

### SPECIAL TERMS AND CONDITIONS

1) Scope of Supply:

Scope of supply & technical specification/requirement shall be strictly as per technical specification requirement stated therein as well as terms & condition of NIEI. Bidders are to follow Section B and C carefully. Any plea of ignorance shall not be accepted after opening of bids. BOQ quantity may be reduced/ increased as per discretion of SWL.

2) Price:

To be quoted in INR per Metric Ton (MT) basis. Variation of weight upto  $\pm 5\%$  is accepted. The tender will be settled on total value of offers comprising of all the items.

3) Terms of Price:

Quoted price shall be firm and fixed till full execution of order and shall be on F.O.R. SWL Howrah basis inclusive of all charges except GST. Unloading of materials is entirely vendor's responsibility.

4) Taxes: Goods and Services Tax (GST) is extra as applicable at the time of supply.

5) Terms of Payment:

100% payment within 30 days after supply and acceptance of the materials at SWL yard.

6) Place of Delivery/Work:

The Shalimar Works (1980) Ltd., 1, Foreshore Road, Shibpur, Howrah – 711102 (near Shalimar Railway Station) within SWL working hours (8 AM to 4 PM) except Sundays & holidays.

7) Delivery Schedule:

Earliest delivery shall be essence of the contract. Delivery of all the materials are to be completed within 7 (seven) days from the date of receipt of LOI / Order.

8) Inspection: Receipt inspection by SWL.

9) Liquidated Damage (L.D.):

For delay in contractual delivery of materials, L.D. will be applicable @ 0.5% per week or part thereof on the undelivered materials subject to maximum 5% of the order value.

10) Guarantee:

The failure of the sub-contractors of the seller will not be accepted as the Force Majeure conditions. Force Majeure occurrence notice will have to be given within 7 days of Force Majeure for a possible delivery extension after verification.

13) Arbitration:

For disputes arising in executing and discharge of the contract from either side the Managing Director of SWL, HRBC Office Compound, Canteen Building, 1st floor, Munshi Premchand Sarani, Kolkata – 700 021 shall act as Arbitrator between the Seller & Buyer.

14) Courts:

The contract is deemed to have been entered into Kolkata and all courses of action in relation to this contract will therefore be deemed to have arisen within the Jurisdiction of the Kolkata Courts.


15) Validity of Offer:


