SECTION – B SPECIAL TERMS AND CONDITIONS

(i) Scope of Supply:

Scope of supply & technical specification/requirement shall be strictly as per technical specification requirement stated therein as well as terms & condition of NIET. Bidders are to follow Section B and C carefully. Any plea of ignorance shall not be accepted after opening of bids. BOQ quantity may be reduced/ increased as per discretion of SWL.

(ii) Price: To be quoted in INR per M.T. (Metric Ton) basis.

(iii) Selection of bidders:

Selection will be made based on total price quoted by the bidder.

(iv) Terms of Price:

Quoted price shall be firm and fixed till full execution of order and shall be on F.O.R. SWL Howrah basis inclusive of all charges except GST. Weighment of materials shall be witnessed by SWL Rep. at Weighment Scale nearer to SWL yard. The Weighment charges are to be borne by the vendor.

(v) Taxes: G.S.T. extra as applicable at the time of supply.

(vi) Terms of Payment:

100% payment within 30 days after supply and acceptance of the materials at SWL yard.

(vii) Place of Delivery/Work:

The Shalimar Works (1980) Ltd., 1, Foreshore Road, Shibpur, Howrah – 711102 (near Shalimar Railway Station, within SWL working hours (8 AM to 4 PM) except Sundays & holidays.

(viii) Delivery Schedule:

Earliest delivery shall be essence of the contract. Delivery of all the materials are to be completed within 7 (Seven) to 10 (Ten) days from the date of receipt of LOI / Order. Part delivery is accepted.

(ix) Inspection: Receipt inspection by SWL.

(x) Liquidated Damage (L.D.):

For delay in contractual delivery of materials, L.D. will be applicable @0.5% per week or part thereof on the undelivered materials subject to maximum 5% of the order value.

(xi) Guarantee:

The materials are to be guaranteed for satisfactory performance for the period of 18 (Eighteen) months from the date of supply and acceptance. Any defects arising within the guarantee period towards manufacturing and performance are to be liquidated forthwith by replacement, if required.

(xii) Risk Purchase:

In case of failure in delivery within the contractual delivery period, SWL shall have the right to cancel the order and procure items from alternative sources at Vendor's complete risk and cost.

(xiii) Force Majeure:

Standard Force Majeure conditions at the seller's own workshops/ establishment shall only be accepted. The failure of the sub-contractors of the seller will not be accepted as the Force Majeure conditions. Force Majeure occurrence notice will have to be given within 7 days of Force Majeure for a possible delivery extension after verification.

(xiv) Arbitration:

For disputes arising in executing and discharge of the contract from either side the Managing Director of SWL, HRBC Office Compound, Canteen Building, 1st floor, Munshi Premchand Sarani, Kolkata – 700 021 shall act as Arbitrator between the Seller & Buyer.

(xv) Courts:

The contract is deemed to have been entered into Kolkata and all courses of action in relation to this contract will therefore be deemed to have arisen within the Jurisdiction of the Kolkata Courts.

(xvi) Validity of Offer:

Offer must be kept valid for 30 (Thirty) days from the date of tender opening.

(xvii) Acceptance:

The bidder has to sign the NIeT document with official seal as a token of their acceptance of the terms and conditions and submit along with technical bid.


