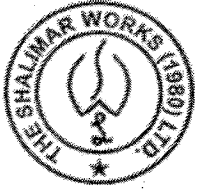



1) Place of Delivery:

2) Delivery Schedule:

3) Order acceptance:

The final evaluation will be made based on total price quoted by the bidder and also based on the satisfactory services from the reputed/reowned user of the similar crane supplied by the bidder.

4) Bidder's Scope of Supply:

- i) Supply of one no. 40 Ton capacity Tyre Mounted Diesel Hydraulic Rough Terrain Mobile Crane as per Section C.
- ii) Commissioning of the crane at our premises, trial run and necessary training to the operators as well as periodical services at free of charges.
- iii) Supply of parts, operation & maintenance manuals (in English language) of adequate in numbers.
- iv) Operational spares for 1 year and tool kit.

5) Inspection:

Inspection will be carried out by the representative of SWL on receipt of intimation well in advance.

6) Price:

Quoted price shall be firm and fixed till full execution of order and shall be on F.O.R SWL Howrah basis. 8) Terms of Payment:

- i) 20% as interest free advance against Bank Guarantee of equivalent amount valid till date of contractual delivery period from any Nationalised Bank/Scheduled Bank as per SWL format. The Bank Guarantee will be released at the time of payment of balance amount.
- ii) Balance 80% with full taxes & duties prior to dispatch of the crane from the manufacturing works, subject to submission of Performance Bank Guarantee for 5% (five percent) value of the Order as per SWL format from any Nationalised Bank/Scheduled Bank with a validity of 13 (thirteen) months from the date of supply of the equipment. Otherwise, 5% (five percent) value of the Order shall be retained till complete of guarantee period. The Bank Guarantee shall have to carry one month claim period.

9) Security Deposit:

Security Deposit of 5% of Order is to be submitted in the form of Bank Guarantee from any Nationalised Bank/Scheduled Bank as per SWL format which will be released after satisfactory supply of the equipment. The Bank Guarantee submitted towards Security Deposit may be converted to Performance Bank Guarantee by extending the validity for additional period covering the period of guarantee. The Bank Guarantee should carry additional claim period of one month.

10) Guarantee/Warranty:

The equipment is to be guaranteed for satisfactory performance for the period of 12 (twelve) months or 1000 (one thousand) hours from the date of commissioning of the equipment or 13 (thirteen) months from the date of dispatch, whichever is earlier. Manufacturer's Test Certificate & Guarantee Certificate are to accompany the supply. Complaint, if raised has to be attended within 24 hours.

Commissioning and trial run of the Crane at SWL premises by the competent representative of the supplier and adequate training to the SWL operators at free of charges.



TECHNICAL SPECIFICATION OF 40 TON CAPACITY TYRE MOUNTED MOBILE CRANE

1	Type & Capacity	Rough terrain hydraulic, self-propelled Mobile Crane of 40 Ton capacity at 3 (three) Meter Radius.
2	Frame & Superstructure	High strength alloy steel welded box section with integral outrigger and fabricated from high quality steel plates & sections.
3	Boom	4 sections, telescopic full power, sequence synchronized boom with single liver control.
4	Boom Elevation & Angle	1 double acting hydraulic with integral holding valve; Minimum (-) 3 degree to maximum 78 degree.
5	Load Indicator	Safe load indicator with audio-visual warning of different parameters.
6	Cabin	Totally enclosed steel construction, 360 degree rotating full vision type with all crane functions, control reverse, driving controls, engine instrumentation & automotive type steering wheel. All windows to be fitted with toughened safety glass, lockable sliding door, cabin interior light, circulating air fan, wiper, horn etc. Operator cabin should be equipped with adequate lights, ventilation and emergency exit door.
7	Swing	Ball bearing swing circle with 360 degree continuous rotation. Planetary Glide-Swing with foot applied multidisc brake, spring applied hydraulically released parking brake, mechanical house lock operated from cabin, free slew facility to be provided.
8	Hoist	Power up & down, grooved drum, planetary reduction with automatic spring applied multidisc brake. Hoist drum fitted with third wrap indicator accommodating non-spin hoist rope- 18/19 Dia & 150 Meter length.
9	Counter Weight	Integral/bolted to superstructure
10	Hydraulic System	2 section gear pump driven through transmission PTO. 4 way double acting pilot operated control valve/flow sharing directional control valve operated by joystick for simultaneous control of multiple crane function. Return line filter with replaceable cartridge & hydraulic cum transmission oil cooler.
11	Hook Block	Minimum 40 Ton, 4 sheaves- 8 fall. Test Certificate of lifting gears are to be submitted.
12	Outriggers	4 hydraulically telescopic beams with integral holding valves positioned 2 nos. in each outrigger housing. Provides steel fabricated quick release type outrigger float for each jack.
