3) Scope of Supply:

Scope of supply & technical specification/requirement shall be strictly as per technical specification requirement stated therein, as well as terms & condition of NIEt. Bidders are to follow Section B and C carefully. Any plea of ignorance shall not be accepted after opening of bids. BOQ quantity may be reduced/ increased as per discretion of SWL.

4) Price: To be quoted in INR per unit basis inclusive of Proof Load Test and Drop Test charges.

5) Selection of Bidder:

The tender will be settled based on item wise lowest offer basis.

6) Terms of Price:

11) Guarantee/Warranty:

The materials are to be guaranteed for satisfactory performance for the period of 24 (Twenty Four) months from the date of supply and acceptance. Any defects arising within the guarantee period towards manufacturing and performance are to be liquidated forthwith by replacement, if required.

12) Liquidated Damage (L.D.):

In the event of delay in delivery beyond contractual period, SWL shall have the right to recover Liquidated Damages @0.5% per week's delay or part there of subject to a maximum of 5% of the order value shall be levied and recovered from the bidder.

13) Risk Purchase:


