SECTION – B SPECIAL TERMS AND CONDITIONS

1) Place of Work:

The work has to be carried out in the premises of SWL at 1 Foreshore Road, Howrah 711102.

- 2) <u>Date of Launching</u>: 27-09-2024 (Tentative).
- 3) Order acceptance:

The final evaluation will be made based on total price quoted by the bidder.

4) SWL's Scope of Supply:

- a) All available materials viz wooden blocks, launching wooden track, joka, slides, wedges, sand box, gravels, packing, coir, nails, base coats, slip coats, grease, oils.
- b) Working space, water, electricity (as long as CESC supply is available), lighting, materials handling facilities as required.
- c) All new/used steel materials as necessary pertaining to launching work.

5) <u>Contractor's Scope of Supply and Work:</u>

- a) Transportation of ground ways, sliding ways, blocks and other materials to working site.
- b) Proper cleaning and washing of ground ways and sliding ways for fresh application of base coat and slip coat.
- c) Maintenance, cleaning and making easy of all the sand boxes to ensure proper flow of the gravels.
- d) Preparation of Soil for launching bed.
- e) Placing of wooden blocks below the shell plates for removing existing skids.
- f) Placing of wooden block, grounding ways, sliding blocks below the vessel sand box/gravel box and sand bags duly filled with sand.
- g) Providing of unskilled, semiskilled and highly skilled manpower for launching work.
- h) Providing of platter, gas cutter, welder etc. for preparation of supports for fore and aft poppets suitably including fabricated supports.
- i) Necessary welding machines and gas cutting sets including electrodes, gas and other consumables.

- j) Application of base coat, slip coat on sliding beds.
- k) Providing heavy duty Hydraulic Jacks of adequate capacity for lifting of the vessel during placement of blocks including supply and fitting of wooden poles (sal balli).
- Any other work and minor materials beyond the scope of supply/work of SWL not indicated above but required for successful completion of the work are to be considered within the scope of the vendor.
- m) Recovery and storage of all wooden blocks in proper place as advised by SWL from river bed including scrap materials immediately after launching of the vessel.
- n) Any other jobs, related to smooth and successful launching of the vessel.

Note:

- a) The successful bidder has to take-up the job immediately on finalisation of the contract/order on receipt of LOI/P.O. Detailed work plan in consultation with SWL authority is to be submitted before commencing the job.
- b) Utmost care has to be taken during execution of the job to avoid any damage/loss of the vessel including machineries installed therein. Wilful damage has to be compensated in full.
- c) Safety of persons engaged in the job is vendor's responsibilities and formalities are to be observed as per rule.

6) Variation in Work:

SWL shall have the right to make variation in the BOQ of the tender at the time of execution of the work. In case of upward variation in the item quantity, contractor will be bound to execute the work as per the BOQ approved rate.

7) <u>Inspection</u>:

By SWL, WBTCL and IWT Directorate, W.B. Govt. as and when required, in stages and also after completion. The jobs are to be carried out as per direction of SWL and with close liaison among departments.

11) Issue of Material:

All free materials to be collected by the contractor from SWL Stores with requisite Issue Pass Slips to be provided by SWL.

12) Material Reconciliation:

The contractor to furnish SWL material reconciliation statement showing details of materials received, materials actually consumed, excess materials returned, wastage etc. along with the last bill. The statement should be submitted with documentary evidence of materials issued / returned / wastage duly accepted by competent authority of SWL.

13) <u>Terms of Payment</u>:

- a) 20% of the order value will be paid as mobilisation advance, if require against submission of Bank Guarantee which will be released after successful execution of launching and recovery of launching materials from the site and proper stowing.
- b) Balance 80% of the order value will be paid on successful completion of launching and fulfilling terms of Work Order including the retrieving and stowage of the launching materials at the proper place directed by SWL.

14) Liquidated Damage (L.D.):

In the event of delay in execution of the work due to the reason attributable to the sub-contractor, liquidated damage @0.5% per week's delay or part there of subject to a maximum of 5% of the order value shall be levied and recovered from the sub-contractor.

15) Risk Purchase:

In case of delay in execution of the work beyond the contractual completion period, SWL reserves the right to out-source the job from any other firm at the risk and cost of the vendor.

16) Prevention of Damage:

Utmost care has to be taken during work at SWL yard to avoid any damage/loss of company's materials, machineries. Wilful damage has to be compensated in full. Safety of sub-contractors men and materials shall their own responsibility. All rules applicable for working within PSU premises are to be adhered to.
