- f) The bidder should have adequate financial capacity. Solvency / Credibility certificate from any Nationalised Bank / Scheduled Bank of not less than ₹ 65,00,000/- (Rupee sixty five lakh) has to accompany the Techno-Commercial bid.
- g) The firm should have average annual financial turnover during the last three years ending 31st March of the previous financial year of at least ₹ 37,50,000/- (Rupee thirty seven lakh fifty thousand).
- h) SWL may verify the credentials of all the bidders from the Credential issuing Authority during bid evaluation, if required.

3) Financial Capabilities:

The applicant should have: (i) access to, or possess available liquid assets and other financial means (independent of any contractual advance payments) sufficient to meet the construction cash flow requirements for the subject contract, of the certain minimum amount specified; (ii) adequate sources of finance to meet the cash flow requirements of works currently in progress and for future contract commitments; and (iii) financial soundness as established by audited balance sheets and/ or financial statements. 4) Disqualification:

Even if an applicant meets the eligibility criteria, he/she shall be subject to disqualification if he/she or any of the constituent partners is found to have:

- b) Records of poor performance during the last five years, as on the date of application, such as abandoning the work, rescission of the contract for reasons which are attributable to non-performance of the contractor, inordinate delays in completion, consistent history of litigation resulting in awards against the contractor or any of the constituents, or financial failure due to bankruptcy, and so on.
- c) On account of currency of debarment by any Government agency.

SECTION – B TERMS AND CONDITIONS FOR SUBMISSION OF OFFER

1) Place of Delivery:

Delivery of the pontoon to WBSTC at the designated place by WBSTC.

2) Period of Delivery:

Within 3 months from the date of receipt of order.

3) Validity:

Validity of the offer shall be 180 (one hundred eighty) days from the date of acceptance of Tender. Thereafter it shall be treated as valid until the tender is withdrawn in writing on expiry of 180 days.

In exceptional circumstances, prior to expiry of the original bid validity period, the SWL may request that the bidders extend the period of validity for a specified additional period. A bidder may refuse the request without forfeiting the bid security. A bidder agreeing the request will not be required or permitted to modify his/her bid, but will be required to extend the validity of his/her bid security for the period of extension.

4) Clarification of Offer:

To assist in examination and evaluation of the lowest offer, the SWL may ask the offerer individually for clarification of their offer including break up of cost, reasons in case of very high / very low offer etc. The response thereof shall be in writing.

5) Right to Reject:

SWL reserves the right to accept or reject any offer and to annul or suspend the offer process and reject all the offers, without assigning any reason, at any time prior to award of contract without any assurance for costs or consequences on the part of the offers.

6) Order acceptance:

The final evaluation will be made based on total price quoted by the bidder.

7) Bidder's Scope of Work:

8) Inspection:

Inspection will be carried out by the representative of SWL, WBSTC and IWT Directorate on receipt of intimation well in advance.

9) Rate/Price:

Quoted price shall be firm and fixed till full execution of order. The rate quoted by the tenderer should be exclusive of GST but inclusive of any other charges. Rate must be quoted in BOQ only.

10) Taxes: Taxes are extra, as applicable.

11) Escalation:

Escalation of quoted price on any ground and consequent cost overrun shall not be entertained under any circumstances till validity of the bid.

12) Variation in Work:

The SWL shall have the right to make variation in the BOQ of the tender at the time of execution of the work. In case of upward variation in the quantity of items, to be included in the BOQ, agency will be bound to execute the said work as per BOQ approved rate.

In case of any variation due to inclusion of any item not included in the BOQ, the agency shall be bound to execute the work as per the rate to be approved by the SWL in this regard. The SWL will arrange for finalization of the said rate maintaining any of the following procedures:

- On the basis of B.O.Q. approved rate in respect of any item of similar nature.

14) Statutory Deduction:

Statutory shall be deducted from the bills of the contractors as per the order of the Government issued from time to time.

15) Security Deposit:

A total amount of 5% of bill value will be deducted and retained as Security Deposit for R/A bills, which will be released after expiry of warranty period of 1 (one) year from the date completion and commissioning of the Project.

16) Performance Bank Guarantee:

A total amount of 3% of work order is to be submitted additionally in the form of Bank Guarantee from any Nationalised Bank/Scheduled Bank as per SWL format which will be released after completion of work. The Bank Guarantee should carry additional claim period of one month. The Bank Guarantee may be revoked in case any of the terms & conditions of the work order & agreement are violated.

17) Warranty:

The bidder will provide Warranty, for the entire constructional work for a period of 01 (one) year from the date of commissioning. If any defect develops meanwhile, the same shall have to be rectified by the builder at his own cost and with instant effect.

18) Governing Condition and Specification:

The Work Order Book shall be kept at the site as well as in the yard of work under the custody of WBSTC's Engineer-in-charge. The Work Order Book shall have machine numbered pages in triplicate. Directions or instructions from WBSTC to be issued to the tenderer will be entered (in triplicate) in the Work Order Book (except when such directions or instructions are given by separate letters).

The tenderer or his authorized representatives shall regularly note the entries in the Work Order Book and also record therein the action taken or being taken by him complying with the said directions or instructions or any relevant point relating to the work. In case of non-compliance of any instruction, claims for payments in respect of such portion of non-complied work may not be entertained based on the records supported by entries in the Work Order Book or any written order.

21) Service of Notice:

Any Notice, correspondence etc. issued to the authorized representative or left to his/her address, will be deemed to have been issued to the tenderer himself.

22) Indemnity:

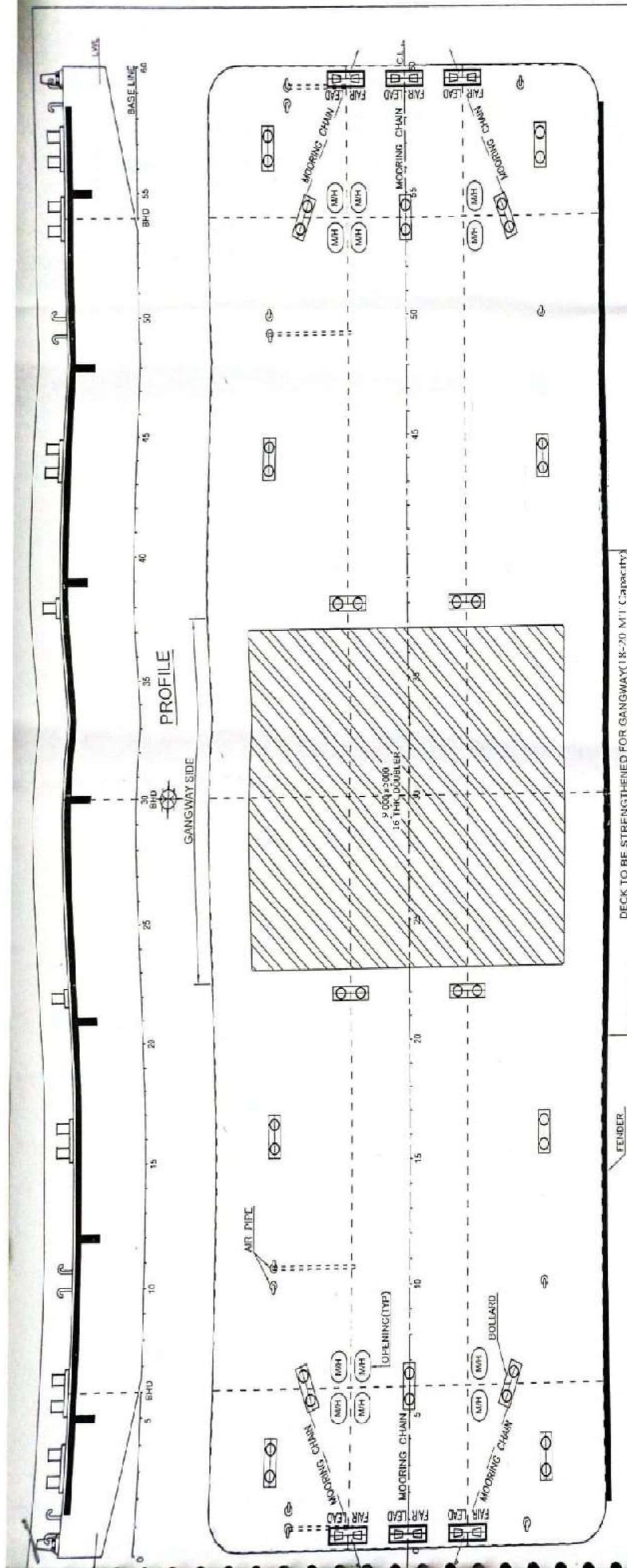

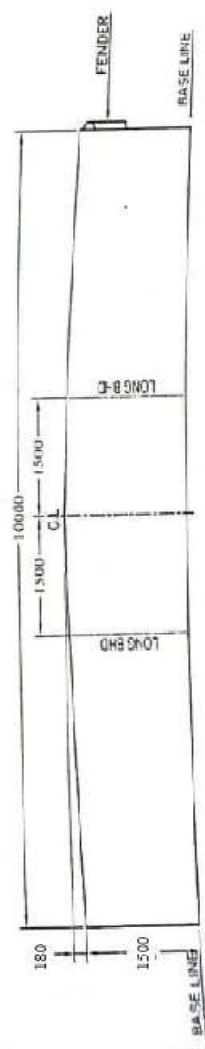


DECK TO BE STRENGTHENED FOR GANGWAY (18-20 MT Capacity)
