SECTION – B GENERAL TERMS AND CONDITIONS

1) Place of Work:

The work has to be carried out in the premises SWL / Babughat Jetty.

2) Completion Time:

30 days from the date of receipt of work order/LOI.

3) Order acceptance:

The final evaluation will be made based on total lowest price quoted by the bidder.

4) Inspection:

Officers of SWL, WBTDCL and The Engineer & Ship-surveyor, IWT, Govt. of West Bengal, wherever required.

The work has to be carried out strictly as per the work order. No additional work is to be undertaken without the written instruction of the competent authority or engineer in-charge which will be followed by confirmatory work order. No claim will be administered for the additional works undertaken without written instruction.

5) Materials & Transport:

The tenderer shall make his own arrangements for procuring and supplying all materials at site at his own cost and by his own labour and transport for execution of the work.

6) Contractor's Scope of Supply:

a) Qualified and experienced workmen for FRP hull & superstructure, welders, skilled & unskilled workmen capable of undertaking the repairing work as stated in Section C, Gas cutting, welding machine with accessories, grinding machines and grinding wheels, cutting wheels, industrial gases, drilling machine, tools & tackles, blowers, safety items required for carrying out the FRP & other work & any other related accessories necessary to complete the job.

b) All materials required to complete the repair of the vessel as per the scope of work stipulated in the tender.

c) Transportation of materials to work site from the respective source of procurement.

7) Contractor's Scope of Work:

- a) To carry out all the work as stipulated in Section – C in conformity with standard ship-building / ship-repairing practice.
- b) Any additional work, if required to be carried out, need to be attended with prior permission from SWL.

8) Price:

The rate should be quoted by the tenderer item wise exclusive of GST but inclusive of all other charges, i.e., cost of material, wage component, plant and equipment and all other things required for repairing of vessel. Price to be quoted as per BOQ.

9) Taxes: As applicable.

10) Deduction of Income Tax:

Income Tax shall be deducted from the bills of the contractors as per the order of the Govt. issued from time to time.

11) Escalation:

No escalation of rates will be allowed on any ground during execution period

12) Terms of Payment:

Payment will be made in stages depending on progress of acceptable quantity of the job. Bills are to be submitted enclosing work done certificate issued by SWL. 90% of each bill shall be paid within 30 days from the date of submission. Balance 10% of the stage bills will be retained and released on completion of 12 months guarantee period as a Security Deposit or Performance Guarantee.

13) Liquidated Damage (L.D.):

Work completion Schedule is to be adhered strictly, liquidated damage of @ 1.0% of the Work Order Value will be deducted from the total bill value for delay in completion of work for every week or part thereof to a maximum deduction amount of 5% of the order value.

14) Risk Purchase:

In case of delay in execution of the work beyond the contractual completion period, SWL reserves the right to out-source the job to any other firm at the risk and cost of the bidder.


